Tuition Policy: The tuition fee is monthly and does not change from month to month unless a class has been added or removed from the account. TCG/HDP does not give credit or refunds for any missed classes. Tuition is due by the **first** of each month. If tuition is not paid by the 5th, on the 6th the credit card on file will be charged. If credit card is declined or rejected a \$35 fee will be charged to your account. Monthly tuition is based on the average of 4 classes per month September 1st through May 31st. Tuition will be pro-rated for new students signing up and not receiving 4 classes their first month only. Students will not be allowed to participate in classes until tuition balances have been paid in full. A separate tuition schedule for recreational classes will apply for the months of June, July and August.

Make Up Policy: As a courtesy TCG/HDP offers (1) make-up class per month. Please contact the office to arrange a make up class.

Gym Closing/Holidays: Monthly tuition is based on a four class month. Some months have five weeks while others have only three during holidays. There are no adjustments to tuition for either of these cases. On an annual basis, they will balance each other out. When Plano schools have closed due to bad weather, please check online or call the Gym to verify if classes will be in session. Holiday closings will be sent out in newsletters and posted ahead of time in the gym. If you are not sure of gym closings, please check with the front desk. **Please help us keep our monthly tuition low by remembering during the Thanksgiving and Christmas Holidays that your child's monthly tuition has already taken these breaks into account.**

Withdrawal Policy: A 2 WEEK WRITTEN NOTICE given to the front office is required if you wish to withdraw your child before the end of May. ONE MONTH'S TUITION FEE will be applied to ALL customer accounts failing to provide proper notice. If you withdraw from a class and you want to re-enroll, a re-enrollment fee will apply. The re-enrollment fee for the first child is \$35, and the second child is \$25, with a family maximum of \$60.

PERMISSION TO TREAT IN AN EMERGENCY

I understand that there are inherent dangers associated with gymnastics/dance and recognize that any physical activity involves risks of serious injury or death, including but not limited to temporary or permanent muscular and skeletal injury and paralysis. Knowing these risks, I and my child(ren) assume all risks, whether foreseen or unforeseen, in connection with my child participation in this activity.

WE AGREE TO DEFEND, INDEMNIFY, HOLD HARMLESS, WAIVE, AND RELEASE TEXAS CHAMPION GYMNASTICS and House of Dance Plano, TOGETHER WITH ITS OFFICERS, TRUSTEES, EMPLOYEES, AGENTS AND MEMBERS, AGAINST ANY AND ALL LIABILITY, CLAIMS AND CAUSES OF ACTION ARISING OUT OF, OR IN ANY WAY CONNECTED WITH MY CHILD'S PARTICIPATION IN THIS ACTIVITY.
